

# DAYTONA TURKEY RUN VENDOR GUIDE

## VENDOR GUIDELINES DO'S & DON'T'S

### DO

**\* FOR THE SAFETY OF YOUR CUSTOMERS \* DURING SHOW DAYS VEHICLES ARE PERMITTED IN VENDING AREA BEFORE 8AM, OR AFTER 4PM ONLY. NO EXCEPTIONS!**

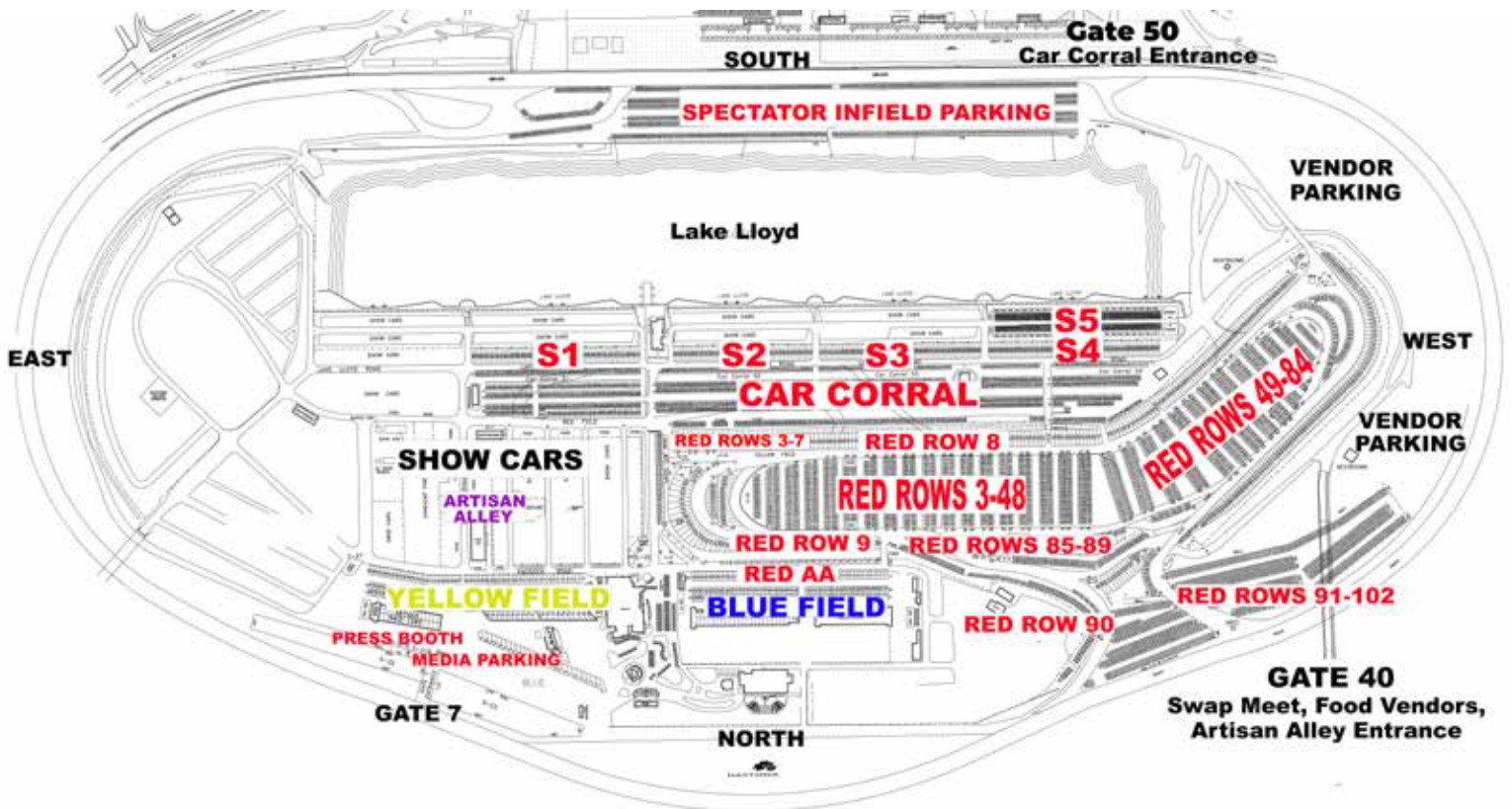
- ◆ Registered vendors may purchase a self-contained RV space in advance of the show. Please contact 386-255-7355 for pricing. Vendors with RV's must get an overnight parking ID card from Registration BEFORE 4pm the day of arrival. RV's can stay overnight the first day of set up through 10am on Monday after the show.
- ◆ Gate Decal and Vendor Space Decal must be affixed to lower, driver side windshield.
- ◆ Car Corral package includes one (1) Car Corral Pass Decal, admission tickets for 2 adults per space and a Gate Decal that designates the gate you are to enter each day. One (1) support vehicle pass per space is available for \$15 each. Additional admission tickets may also be purchased as needed.
- ◆ Swap Meet packages include one (1) Vendor Pass Decal, admission tickets for 2 adults per space and a Gate Decal that designates the gate you are to enter each day. One (1) Support Vehicle Pass is available for \$15. Multiple space packages include one (1) Vendor Pass Decal for every two (2) spaces purchased, admission tickets for 2 adults per space (for vendor to enter) and a Gate Decal that designates the gate you are to enter each day. Additional admission tickets may also be purchased as needed.
- ◆ Pets are permitted, but please keep all pets on a leash at all times and pick up after them.
- ◆ Your Customers may pick up purchased items after show hours by providing proof of receipt and your space location at Gate 40 for entry.
- ◆ On show days everyone entering the speedway must have a ticket, including vendors. No exceptions. Tickets will be punched before entering and hands stamped before leaving the speedway.
- ◆ Pre-register for upcoming events on all set up days from 9am to 4pm and on show days each morning until 10am at the Swap Meet registration tent at GATE 40.
- ◆ Please direct guests needing assistance with removal of purchased parts during show hours to contact Vendor Dispatch Assistance at 386-681-4284. Guests must be present with item.
- ◆ Swap Meet Vendors are required to attend all event days, including Thanksgiving and Sunday.
- ◆ **Approved Mobility Devices:** Single-seat scooters for one person. Two-seat scooters for two people.(maximum) Must be a commercially manufactured, 3-wheeled or 4-wheeled scooter. Dimensions no larger than 32 inches wide by 63 inches long. No roofs allowed on scooters. Electric-powered scooters only. (no gas)

### DON'T

**\* Swap Meet Vendors - If you arrive after 8am or before 4pm you will not be permitted to drive to your space for the safety of our walking spectators. NO EXCEPTIONS!**

- ◆ **Not Permitted:** Golf carts of any size. No trailers or towed objects allowed with the scooter. Scooters exceeding the size limitations. One wheeled or two wheeled devices. Bicycles, unicycles, skateboards, rollerblades, wheelies, scooters, or any other device that does not comply with the Approved Mobility Device section above.
- ◆ **Important Rules:** Operate scooters at a walking pace only. Do not leave scooters unattended or block walkways, rows, or designated spaces. You must be 18 years of age or older to operate a scooter without adult supervision.
- ◆ RV's - Do not run generators from 11pm - 6am. No tent camping or sleeping in your vehicle.
- ◆ All generators must be run quietly. Vendors will be required to shut off generators that disturb other vendors.
- ◆ Banners are not permitted anywhere on property unless previously approved. If your space is along a fence line you may hang your banner directly behind you **facing your display.**
- ◆ Aisles between rows must stay clear of parked cars at all times. Please be sure vehicles are properly parked to prevent being towed.
- ◆ The Car Corral is for selling operational cars and trucks only. Motorcycles, trailers and other oversized vehicles may be sold in the Swap Meet area only. Support vehicles will be permitted into Car Corral during set up days ONLY! **No support vehicles on show days, at any time, in the Car Corral.**
- ◆ The selling of golf carts, disability scooters and t-shirts are not permitted. **NO EXCEPTIONS!** Doing so will result in removal from all events.
- ◆ In the Swap Meet the selling of: Daytona Turkey Run merchandise, Weapons (lethal or non-lethal, to include but not limited to BB and pellet guns, knives, bow and arrows, stun guns, brass knuckles, mace), obscene materials (to include but not limited to signs/photos of obscene gestures and messages), sunglasses, scooters, bicycles, non-automotive related children's toys, antiques, glassware, food/drinks, animals, T-shirts, confederate flags, political or any non-automotive related items are prohibited. If there are any questions about whether your items are permitted please call 386-255-7355.
- ◆ Swap Meet and Car Corral spaces are non-transferable.
- ◆ **No walking around the event selling goods or services. Only sell in your assigned space. Violators will lose their Vendor/Swap Meet space.**

**\*Any vendor not adhering to the above will forfeit their space and be escorted from the property.**
